# Motor Learning/Control

Keynote Speaker: Dr. John Hollerbach

Department of Psychology Massachusetts Institute of

Technology

Dr. John Hollerbach, professor in the Department of Psychology at the Massachusetts Institute of Technology will be the major speaker in the motor learning/control section. Dr. Hollerbach, a recent Ph.D. from the Artificial Intelligence program at MIT has conducted very elegant and theoretical work in two areas. First, an analysis of handwriting from an oscillatory spring model. Second, an analysis of control of two dimensional move-These works have been published in Biological Cybernetics in 1981 and 1982. Finally, Dr. Hollerbach has written an article in one of the most recent Trends in Neuroscience concerning minds, computers and motor control. His talk will center around this article and his most recent article with Tamer Flash in Biological Cybernetics.

# 1984 NASPSPA CONFERENCE

The 1984 NASPSPA Conference will be held in conjunction with the 1984 Olympic Scientific Congress. The Congress will be held from July 16 to July 26. NASPSPA is to be responsible for coordinating all papers dealing with motor learning/control motor development and sport psychology. NASPSPA will be housed in a single hotel and will have its sessions in the mornings. The afternoon sessions will be given up to Congress themes (e.g., Children in Sport) which will bring speakers from many disciplines together to address a topic. At the present time, 12 National and International organizations have agreed to hold their Annual Meetings in conjunction with the Congress. This is a unique opportunity for NASPSPA to act as a host to scientists from all over the world and to influence the substitive content of the Congress.

# 1985 NASPSPA CONFERENCE

The 1985 NASPSPA Annual Conference will be hosted by the Louisiana State University in cooperation with the University of Southern Mississippi. Dates for the conference have been set for May 25-28, 1985. The conference center has self-contained meeting and recreational facilities and is well suited for the annual conference.

#### Publications Director's Report (Penny McCullagh-Wallace)

- The format for the 1982 NASPSPA Membership Directory was presented. It will be published in December, 1982 and mailed to members shortly thereafter. The directory will be published every other year. Cost estimates for this year's directory were presented.
- The cost of processing and mailing the Fall, 1982 NASPSPA Newsletter was substantially higher than usual (\$842.04) due to the inclusion of an eight-page addendum detailing 1) Ethical Standards for the Provision of Services by NASPSPA members, and 2) Guidelines for Psychological Testing within Sport and Physical Activity Settings. # President-Elect's Report (Bob Schutz)

An update on the preparations for the 1983
 Conference at Michigan State University was
 presented. The program committees have
 been appointed and are progressing on schedule (Please see details elsewhere in this
 Newsletter). The deadline for submission
 of papers, posters, and symposia is February
 11, 1983.

# Past President's Report (Tara Scanlan)

- Nomination procedures for Executive Committee
  positions were discussed. It was suggested that
  attention be given to preserving balance on
  the Executive Committee with respect to area
  of interest, gender, and institutional affiliation.
- 2. Additional guidelines for the selection of committee members for the NASPSPA Early Career Distinguished Scholar Award and the NASPSPA Distinguished Scholar Award were discussed. It was agreed that the following guidelines should be added to existing guidelines:

  Anyone submitting a nomination or writing a letter of support for a candidate is disqualified from serving on the selection committee, and 2) no member of the Selection Committee may be from the same institution as a nominee or have been the doctoral advisor or advisee of a nominee. If any of the above restrictions apply to the Past President (who chairs the Scholar Award Committees), he or she will refuse to exercise the right to vote.

The selection committee has been chosen in the event someone is nominated for the awards. Members of the committee who will serve a two year term are Lolas Halverson, Daniel M. Landers and Ron Marteniuk.

#### President's Report (Glyn Roberts)

- 1. Glyn Roberts reported that he had received written notification from Dr Miroslav Vanek, President of the Intrenational Society of Sports Psychology (ISSP) approving NASPSPA affiliation with that society. Written acceptance of the conditions of this affiliation and annual dues (\$100) will be forwarded to ISSP. The NASPSPA President or his/her delegate will represent NASPSPA at meetings of the ISSP Managing Council. The President will appoint a NASPSPA representative to attend other ISSP meetings.
- It was announced that tax-exempt status for NASPSPA was filed with the state of Illinois on June 16, 1982.
- It was also announced that the Ad Hoc Committee of Past Presidents will be meeting early in 1983 (for the charge of this committee please see the Summer Newsletter).

# Policy Manual

The NASPSPA Policy Manual will be completed within the next several months. The Executive Committee agreed that as a matter of policy all NASPSPA members should be issued a) one copy of the document Ethical Standards for the Provision of Services by NASPSPA Members, b) one copy of the document Guidelines for Psychological Testing Within Sport and Physical Activity Settings, and c) one copy of the most recent NASPSPA Membership Directory.

#### New Business

# 1. Journal Discount Policy

After a discussion of the discount policy it was agreed that the discounts for the Journal of Motor Behavior and the Journal of Sports Psychology will be offered to professional members in 1983. The new discounted price for each journal is \$16 (regular individual subscriptions are \$35 for JMB and \$20 for JSP). Non-U.S. members will be asked to pay additional postage costs of \$5 for JMB and \$3 for JSP. The Executive Committee decided not to continue with the policy of discounting Motor Skills: Theory into Practice. The publication lag on this journal is now 12 months and the Executive Committee has informed the Editor of MS:IIP that the journal may reapply for the discount privilege when the issues are current.

#### 2. 1984 Conference

Dr. Dan Tripps, Executive Director of the 1984 Olympic Scientific Congress met with the Executive Committee to explain the current progress of planning for the Congress. Following Dr. Tripps' presentation, the Executive Committee unanimously reaffirmed the decision to hold the 1984 NASPSPA Conference as an official part of the 1984 Olympic Scientific Congress to be held in Eugene, Oregon, from July 19th to July 26th. The Executive Committee had had some concerns, but these were resolved with Dr. Tripps. The unique opportunity for NASPSPA to contribute to the planning of the Congress and for NASPSPA to be responsible for the selection and hosting of all major contributors to the areas of concern to NASPSPA were the primary reasons for the Executive Committee to commit NASPSPA to the Congress.

The Executive Committee unanimously agreed that Glyn Roberts serve as the liaison of NASPSPA to the Congress. The next President-Elect would be responsible for the planning and content of NASPSPA's program as has been the case in the past.

#### 3. 1985 Conference

The 1985 Conference will be held at Louisiana State University, Baton Rouge, Louisiana, on the 25th-28th of May (Not over Memorial Day weekend).

#### 4. Associate Memberships

Following discussion of the concept of an Associate Membership for scientists not formally associated with NASPSPA (suggested by Steve Wallace), it was agreed that major speakers who present at the Annual Conference be put on the NASPSPA mailing list for one year and be invited by the NASPSPA President to become a regular member of our Society.

# 5. Clarification of the Role and Scope of the Secretary-Treasurer's Office

The Committee attempted to clarit, several duties of the office of Secretary ineasurer. It was concluded that the person serving in this capacity should: a) coordinate travel plans for the Annual Fall Executive Committee Meeting; and b) provide the Publications Director with updated membership information for NASPSPA mailings.

It was agreed that an amount of \$400 be made available to the Secretary-Treasurer to be used, if needed, to hire part-time help during peak-demand periods. The membership of NASPSPA is increasing substantially with a subsequent increase in the time commitment of the Secretary-Treasurer.

The meeting was adjourned by President Roberts.
The next Executive Committee Meeting will be held
at Michigan State University prior to the annual
Conference.

# NASPE SPORT PSYCHOLOGY ACADEMY SOLICITS ABSTRACTS FOR THIRD ANNUAL DISSERTATION AWARD

The NASPE Sport Psychology Academy has announced the third annual dissertation award competition and solicits nominations for and applications from individuals whose dissertations were completed between January 1, 1982 and December 31, 1982. Information and forms may be obtained by contacting Dr. David Pargman, Chairman of the Awards Committee.

The recipient of the award will be invited to speak briefly at the Sport Psychology Academy meetings at the Annual American Alliance for Health, Physical Education, Recreation, and Dance Conference in Minneapolis, MN to be held April 7-11, 1983. The award will be presented at that time. Each dissertation abstract will be judged by members of the committee and by experts on the subject of the thesis, as necessary.

Abstracts should be sent to David Pargman, 201 Montgomery Gym, Department of Movement Science and Physical Education, Florida State University, Tallahassee, Florida 32306. Following a review of the abstracts, the Awards Committee may request a copy of the complete dissertation for the final review and selection.

#### FEATURED ARTICLE

In the Winter 81-82 edition of the Newsletter two articles were published addressing the issue of the publishing game and authorship of scientific articles. The following article addresses another concern related to the publication of scientific research.

#### SUPPORT OF SCIENTIFIC JOURNALS

by Philip H. Abelson (Science, 1981, October 23, 214(4519)(Copyright 1981 by the American Association for the Advancement of Science) is reprinted with their permission.

"Offices of scientific societies and editors of their journals are becoming apprehensive about the future of scientific publication. A system that has served science and society well is moving into a phase of increasing financial stress. The Royal Society has conducted a study of scientific publication in the United Kingdom.\* A major conclusion is that "a combination of pressures will very soon put the scholarly scientific publication system of the United Kingdom, as of other countries, under considerable strain. Journals are increasingly dependent on the international library market for their income; libraries are suffering cuts in their budgets and are looking for ways to economize; they have to cancel subscriptions to some periodicals on the assumption that material from them if requested can be obtained as loans or photocopies under some interlibrary cooperation scheme.... Scientists themselves assume that the journal and library system will continue and in general do not wish to see restriction on photocopying. Publishers see this as a severe threat to their existence. New specialized journals continue to be launched.... These new and often expensive journals intensify the librarian's problems.

Prior to World War II, journals published by scientific societies in the United States received most of their financial revenues from members. Today only a minor fraction are supported in that way. Instead, the burden has been shifted largely to the libraries. An example is the structure of financial support for the Journal of Biological Chemistry, sponsored by the American Society of Biological Chemists. This periodical publishes about 12,000 pages a year. It has almost 7000 subscribers, consisting of 5000 nonmembers, who pay \$285 each; 1200 members, who pay \$100; and 650 students, who pay a nominal rate. Authors are charged \$35 a page, but the page charges are not always honored. The result is that nonmembers, mainly libraries, provide about 75 percent of the support. Practices vary among the major societies. A few charge up to \$140 a page; some have no page charge. Almost all have higher subscription rates for nonmembers than for members.

Many scientific journals are owned by commercial publishers. They obtain almost all their revenues from libraries. Subscription rates are high, sometimes thousands of dollars a year. Costs range up to 20 cents per page and more, whereas the scientific societies provide material to libraries at usually no more than 3 cents per page.

For more than a decade, costs of periodicals have increased faster than inflation, while library budgets have usually barely kept up with it. Librarians have sacrificed services and procurement of books to maintain their serial collections. Now many find that they must curtail subscriptions. The libraries cannot be counted on to continue to be the sole or major support of scientific periodicals.

The publication of refereed journals is crucial to the health of science. If present modes of support are curtailed, costs must be reduced or additional revenues obtained from other sources. The best way of cutting costs is to reduce the number of pages printed. Today many scientists give priority to publishing as many items and pages as possible. If the goal were to craminformation into a limited space, the number of pages could be reduced by a factor of 2 to 4.

Additional revenues might be obtained from page charges. After all, research is not complete until it is published. The federal government might be asked to a poort scientific publication directly; at present, there is little chance that it will do so. In the end, it may be necessary for the members of scientific societies to contribute more. They already provide substantial support by refereeing articles, but in the future they may be called on for much larger membership fees." --Philip H. Abelson
